Therefore, the Managing Committee, in the interests of all its members and to ensure that the re-development process is not delayed due to technical issues has decided to have revoting for appointment of PMC, under the aegis of Association, when members of all the societies, who are part of the Association, will come together and jointly vote for appointment of PMC.

Further, in the interests of all the members of the Association and to ensure that the process of re-development is carried out in a timely and efficient manner it is necessary that all the Association Societies should specifically authorize the Association to carry out all the acts necessary for the purposes of re-development.
